I accept full responsibility for any and all damages or thefts that occur during my rental for all members involved in my event. I agree that if any persons are added during the trip, who are NOT part of the original group, it will be at the discretion of the Contracted Person/Driver ONLY (not to exceed 16 or 20 passengers. NO STANDEES.) I have the right to inspect the F.U.N. Bus prior to my trip and report any noticed damage. I have accepted the F.U.N. Bus in good faith and agree to the above listed price. I agree to pay for all services rendered at the time of pick-up, and any additional hours at the trips end. I will extend these rules to persons of my group or any added persons during the trip.

Rules and Regulations:

- We accept checks, cash, credit cards (VISA, Master Card, Discover, and American Express), money orders. Checks and credit cards with proper ID.
- Cancellation Policy: If you cancel booking prior to your event, you will be responsible for 50% of rate if F.U.N. Bus is unable to re-book your date. If cancelled within 14 days prior to your event you will be responsible for 100% of rate charged if F.U.N. Bus is unable to re-book your date.
- Payment of full lease is to be paid to the driver upon arrival. \$30.00 fee for returned checks or bad credit card processing. (Fee will be paid in Cash or Money Order only.)
- Starting and ending times must be enforced. (Subject to driver/bus availability.)
- There is NO SMOKING allowed on the bus
- For any actions such as harassment, fighting, violence, damage to equipment and/or bus, toward the driver, staff or anyone else in or around the F.U.N. bus, the driver reserves the right to terminate the trip. The client will be responsible to find other transportation and forfeits full fare as a result. Adult movies viewed ONLY with all consent. Alcoholic beverages are not allowed outside of the bus during the trip.
- By signing this contract, the above client agrees to assume full responsibility for any damages or items removed belonging to the company, by client and/or any members of their party. All items will be charged at replacement cost, plus \$25.00/hour labor. (This includes CD's and movies.)
- If a passenger should vomit in or on the F.U.N. Bus, there will be a minimum charge of \$100.00 (payable to driver). Additional charges may apply if damage is done as a result, or professional cleaning is needed. Driver will pull over when safe to do so.
- If your party chooses to have food on the bus there will be a \$25.00 fee for cleanup. This includes JELLO-SHOTS.
- Tips: Gratuity for your driver HAS NOT been included in your fee. A tip for showing your groups' appreciation for being well served in a professional/courteous manner. Normal tip is 15-20%. Tip can be added on to credit cards if needed. A minimum of 15% gratuity will be charged to credit card on file if other arrangements are not made.
- Illegal substances are prohibited! Under 21 consumption of alcohol is prohibited.
- F.U.N. Bus cannot by law supply alcohol to/for clients. Guests must provide their own alcoholic beverages.
- F.U.N. Bus is not responsible for injuries or accidents in and around the F.U.N. Bus. Alcohol impairs motor skills, balance and judgment. Clients are asked to remain seated while bus is in motion. Move about at your own risk. Please, use caution on steps.
- F.U.N. Bus is NOT LIABLE in cases of unexpected vehicle breakdowns, accidents, severe weather or anything that may delay a timely arrival or cause a cancellation of the trip. In the event of a cancellation due to mechanical or "No Travel Advisory", trip may be rescheduled for another date if possible. Client will be notified as soon as possible to let them know of mechanical problems or adverse weather that may postpone trip times. In the event of severe weather or road closures, all clients will be responsible for their own hotel rooms and meals. Additional hours are not charged during this time.
- Bar/F.U.N. Bus Agreement: If a client or member of their group is kicked out of a bar, night club or eating establishment, they will also be removed off the bus and will be responsible for their own transportation at that time. Any money they paid for the service will be forfeited at that time at driver's discretion.
